Dies unter anderem auch aufgrund der verschlechterten Ertragskraft und eingetrübten Konjunkturaussichten, so dass wir die Risiken für die zukünftige Geschäftsentwicklung und Liquidität ebenfalls höher einschätzen.

Daher nehmen wir eine Herabstufung des Ratings auf B bei negativem Ausblick vor.
